Positive Contribution	<ul style="list-style-type: none"> - Young people are supported in developing socially and emotionally. - Young people, particularly those from vulnerable groups, are supported in managing changes and responding to challenges in their lives. - Action is taking to reduce anti social behaviour and re-offending. - Young people are encouraged to participate in decision making and in supporting the community. 	<ul style="list-style-type: none"> - Courses are developed to enhance all life and key skills, with supporting mentors available. - Young people are made aware of the changes, challenges and barriers that they will face within the media and entertainment industry. - Positive behaviour and attitude is only accepted on our courses as well as information available on the criminal justice system and sentencing for offending and re-offending. - Young people will choose their own rules to follow to make them aware of how they would like to be treated. They are encouraged to carry on acting this way.
